Tuition at Casa Montessori, as at all private schools, is annual tuition determined by an annual budget and reflects all costs involved in the operation of the school for that year. We work diligently to keep our tuition as reasonable as possible while still maintaining our highest dedication to giving your children the best educational opportunities available.

Realizing that a single annual payment, or even two individual semester payments may be prohibitive for some families, we have developed an installment program that divides the annual tuition into ten (10) installment payments. Our school year consists of 180 days, hence:

$$180 \text{ days} \div 10 \text{ installments} = 1 \text{ payment every 18 days}$$

Refunds

Installment payments are *not* determined by the number of days your child attends school; installment payments are simply an easier way to pay the annual tuition while still allowing us to meet our financial obligations related to annual operating costs. Our faculty members and staff are employed for 10 months and as the State of California strictly limits the number of children per teacher, hiring decisions, class assignments and the annual budget are made accordingly. Tuition due and owing fully accrue as of the One Annual Payment due date and is nonrefundable.

All tuition installments are due and payable on the due dates noted below; if payment is not made within ten (10) days following the due date, you will be charged a late fee of **\$10.00** and your child will not be enrolled for the following month. To reinstate your child, you must re-register and pay all past due fees. **No exceptions will be made.**

Checks returned for insufficient funds will be charged an additional fee of \$35.00 and may also be charged a late fee if they are not fully funded before the 10-day grace period expires.

When making a payment, please record your child's name on your check, any third parties paying for your child should also include your child's name on their check to ensure prompt and accurate posting to your account.

EXHIBIT A – ADDITIONAL TERMS AND CONDITIONS

These Additional Terms and Conditions are incorporated into the Tuition Agreement. By entering the Tuition Agreement, you consent to these Additional Terms and Conditions.

1. Governing Law & Venue. This Agreement shall be governed by the laws of the State of California without regard to conflicts of law rules. Any litigation arising under this Agreement shall be brought in a court of competent jurisdiction in Los Angeles County, California, and the parties hereby consent to the jurisdiction of those courts.
2. Limitation of Liability. UNDER NO CIRCUMSTANCES WILL CASA MONTESSORI OR DIRECTORS, OFFICERS, SHAREHOLDERS, EMPLOYEES OR AGENTS BE LIABLE TO CLIENT FOR ANY SPECIAL, INDIRECT, INCIDENTAL, EXEMPLARY OR CONSEQUENTIAL DAMAGES OF ANY KIND OR NATURE, ARISING OUT OF OR IN ANY WAY RELATED TO THIS AGREEMENT, EVEN IF IT KNOWS OR SHOULD HAVE KNOWN OF THE POSSIBILITY OF SUCH DAMAGE. IN NO EVENT SHALL CASA MONTESSORI'S LIABILITY UNDER THIS AGREEMENT EXCEED THE FEES YOU ACTUALLY PAID DURING THE 6 MONTHS PRIOR TO THE INCIDENT CAUSING THE LOSS.
3. Force Majeure. Except with respect to payment obligations, no party shall be liable for, nor shall such party be considered in breach of this Agreement due to, any failure to perform its obligations as a result of a cause beyond its control, including any act of God or a public enemy or terrorist, act of any military, civil or regulatory authority, change in any law or regulation, fire, flood, earthquake, storm or other like event, disruption or outage of communications, power or other utility, labor problem, unavailability of supplies, pandemic or other public health emergency, or any other cause, whether similar or dissimilar to any of the foregoing, which could not have been prevented by such party with reasonable care. The time for performance required of the affected party shall be extended by the period of such delay provided the party is exercising diligent efforts to overcome the cause of such delay.
